Please be on the lookout for a Welcome email from InfoArmor that will be sent to the email address you provided when you enrolled in the InfoArmor plan (you will receive a letter if you did not provide your email). This letter/email will contain additional information on what to expect for communication from InfoArmor. Members also have continual access to his/her personal online dashboard where he/she may view, update, or change identity information and solicitation reduction opt outs, and access the Identity tool at any time.
